WARRANTY INFORMATION

For Australian consumers: Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.

The warranty on Bogaard products is for a period of twenty four (24) months from the date of fitting to a vehicle. The warranty covers parts and workmanship of the product only and liability, if any, does not extend whether in tort or contract to any consequential losses or losses that exceed the cost price of the Bogaard product. Any problems arising from the installation of the product is beyond the control of the manufacturer and is specifically excluded from the warranty. Any costs arising from the installation, removal or refitting of the product in the event of a malfunction is excluded from this warranty. All warranty service will be carried out at the manufacturer's premises at Ballina, NSW. Postage or any other transport costs to the manufacturer's or distributor's premises is the owner's responsibility. However the manufacturer will bear the return postage cost after any warranty repair. In the event of any attempted repair to or tampering with the product during the warranty period, the warranty shall be void.

The benefits provided to Australian consumers by the warranty are in addition to other rights and remedies available to the consumer under Australian Consumer Law.
